Premium quality, a positive user experience, standing behind our products, all of which are backed by a five (5) year limited warranty. Street Flow Stainless warrants that all of its exhaust products are free from manufacturer material and workmanship defects. Street Flow Stainless extends the following five (5) year limited warranty to the original purchaser of its products, warranty guidelines are as follows:

- **Five (5) Year Limited Warranty applies to all Street Flow stainless steel mufflers against manufacturing defects.**
- **This warranty will be null and void if the product is not stamped with the official Street Flow logo.**

This warranty does not apply to any Street Flow Stainless exhaust product(s) which have been installed on any commercial or racing application. Exclusions also encompass but are not limited to product improperly installed, altered product, product subjected to misuse or damage, a misused product from an accident, collision, undercarriage road impact, and/or debris. This warranty policy shall not apply to normal wear, cosmetic issues such as coatings and material discoloration. This warranty policy does not cover or include the cost of removal, labor, reinstallation of any product, outside service(s), a product(s) from another manufacturer/business, transportation or towing costs, shipping expenses, and/or installer services. Due to the variations per application and sound being subjective, this warranty policy does not warrant sound. This warranty is non-transferable.

To properly submit a claim for warranty under the terms of this limited warranty policy, the original product purchaser must file a warranty claim through the initial retailer/seller. All warranty submissions will require the original proof of purchase during the time of claim submission. The original exhaust product must also be returned (any freight prepaid) and exchanged for a new exhaust product of the same part number. All returns must have a Return Material Authorization (RMA) number issued by Street Flow Stainless before the defective product(s) being returned. If the product was purchased directly from Street Flow Stainless the warranty claim must be submitted via email: Warranty@Street-Performance.com. We will repair any product that proves to be defective in materials or workmanship defects. If the repair is not possible, we will either replace your product with a new unit or with a new product of similar composition and price or issue a refund for the full purchase price of your product, at our sole discretion. There is no charge for inspection.

In no event shall Street Flow Stainless be held liable for any direct, indirect, special, incidental, or consequential losses and/or damages. Including but not limited to interruption of business, loss of business, and/or loss of profit. Some states do not allow the exclusion or limitation of incidental or consequential damages, so the above limitations or exclusions may not apply to you.
